Dear Sheriff Hoffman

On April 3<sup>rd</sup> 2024. I sent the below email to your office.

I have been associated with law enforcement the entirety of my life. This includes:

1. Military Police
2. Armed Forces Police
3. Municipal Law Enforcement &
4. Federal Law Enforcement via Atlantic City Investigations

Educationally I started as an undergrad at East Carolina University. Then Studied Elements of Law Enforcement @ Los Angeles Comm College (LACC); Okinawa Japan. I attended several other Universities and received (2) 4 year degrees.

The first at ECSU. Elizabeth City State University: A B.A. Major in Poly Sci and Minors in Criminal Investigations & Modern Mass Media.

My second 4 year degree was issued by a Florida Names Sake. Full Sail University, Orlando – Winter Park Fl. Where I received A B.S. in Digital Cinematography. Or Film Maker. This

degree was just a couple of years ago. I have 8.5 years plus of higher levels of education and 1 year in Military & Federal Law Enforcement training. I sometimes tell myself I have enough upper level education for a PHD.
